## "REFER A FRIEND" CONTEST

---

ILIRIKA borzno posredniška hiša d.d., Ljubljana, Slovenska cesta 54A, 1000 Ljubljana (hereinafter referred to as "ILIRIKA or the Organiser") hereby sets out the conditions for participation in the contest "Refer a Friend" (hereinafter referred to as the "Contest").

### Definitions

Existing client is a natural person who has opened a trading account with ILIRIKA before or up to 1 February 2022 inclusive.

The cash benefit is a benefit of EUR 25,00, which is available to an existing client who fulfils the conditions for participation in the Contest.

The Contest runs from 1 February 2022 to 1 May 2022 inclusively.

### Conditions for Participation in the Contest

An existing client who has opened a trading account with ILIRIKA before or up to and including 1 February 2022 and who recommends ILIRIKA's services to one or more persons (hereinafter referred to as the "Client") shall be eligible to receive the cash benefit. Each person to whom ILIRIKA's services have been recommended by a Client shall then, upon opening a trading account with ILIRIKA, provide the Client's name, which shall be done by e-mail [online@ilirika.si](mailto:online@ilirika.si) or by telephone 01 300 24 61 (hereinafter referred to as the "New Client"). The "Client" and the "New Client" may also be referred to individually as the "Participant" or collectively as the "Participants."

The New Client must comply with the conditions for opening a trading account as set out in the applicable terms or as provided for by applicable laws. ILIRIKA may refuse an application for the opening of an account without giving any reasons.

Within 3 business days of the successful opening of a trading account with ILIRIKA by a New Client, the Client and the New Client will receive a cash benefit of EUR 25.00 in their trading accounts, of which the Client and the New Client will be notified via the ILIRIKA Online portal.

Persons employed by the Organiser and persons employed by the companies participating in the Contest are not allowed to participate in the contest. The same applies to their immediate family members.

### Cash benefit

A Client and a New Client who opens a trading account with ILIRIKA based on a Client recommendation will each receive a cash benefit of EUR 25.00 on their trading accounts within 3 business days.

The cash benefit is non-transferable and non-exchangeable. The cash benefit cannot be paid in cash. Participants shall not be entitled to claim benefits other than or in excess of those set out in the Contest.

The cash benefit received will be used by the Client and the New Client exclusively at ILIRIKA for the purchase of financial instruments via the ILIRIKA Online portal.

The Organiser shall not be liable for any liability or costs incurred by the Client or the New Client, as the case may be, after the receipt of the cash benefit and arising as a result of the actions of the Organiser and/or third parties organising and executing their obligations in relation to the Contest.

### **Data Privacy**

By participating in the Contest, the Participant authorises ILIRIKA, as the controller, to collect, manage, process and store the personal data collected in connection with the Contest (e.g. but not limited to name and surname, e-mail address, address, place and postcode, telephone number) in its personal data collection for the purposes of the Contest and to use it for marketing and promotional purposes related to the Contest in all forms of media, but only to the extent of the consent given by the Participant. i.e. the Participant's name and surname, e-mail address, address, place and postcode, telephone number.

The Participant expressly consents that the personal data may be shared with all ILIRIKA's affiliates in accordance with applicable law for the purpose of unifying operations, control and performance of the contractual relationship between them.

In accordance with the applicable data privacy laws, the Participant has the right to access, supplement, rectify, restrict, transfer or delete the personal data processed in relation to him/her, which the Participant shall exercise by means of a written request sent to ILIRIKA borzno posredniška hiša d.d., Ljubljana, Slovenska cesta 54A, 1000 Ljubljana or [vop@ilirika.si](mailto:vop@ilirika.si).

The Participant has the right to lodge a complaint with the applicable data privacy authority, if he/she considers that his/her personal data is being processed in breach of the applicable data privacy regulations.

The Organiser shall implement technical and organisational security measures to protect personal data. The Participant acknowledges that the mere transmission of data over the Internet or any wireless network is risky and beyond the control of the Organiser.

### **Dispute resolution**

Any disputes, claims or disagreements between the Participant and ILIRIKA in connection with the Contest shall be settled amicably and out of court in the manner and according to the procedures set out in ILIRIKA's Rules on Out-of-Court Dispute Resolution, which are available to the Participant at ILIRIKA's offices and on the website [www.ilirika.si](http://www.ilirika.si).

In the event an amicable settlement of the dispute is not possible, the competent court for the settlement of disputes shall be the competent court in Ljubljana.

## **Final provisions**

ILIRIKA, when providing the services covered by the Contest, complies with and enforces the provisions of the applicable AML regulations.

Anything not provided for in the Contest and the General Terms and Conditions for each service shall be subject to the contractual provisions and the General Terms and Conditions for each service and to the provisions of the applicable legislation.

ILIRIKA shall not be liable for any damages incurred by the Participants as a result of their participation in the Contest or as a result of the acceptance of the cash benefit.

These rules will come into force on 1 February 2022 and will remain in force until 1 May 2022.

The Organiser reserves the right to amend the Contest rules due to technical, commercial or public reasons.
